- 4. Products covered (HS or CCCN where applicable, otherwise national tariff heading. ICS numbers may be provided in addition, where applicable): Windscreen washing fluids, defrosting fluids and denatured alcohol containing methanol in quantities equal to or greater than 0.6% by weight.
- **Title, number of pages and language(s) of the notified document:** Draft Commission Regulation amending Annex XVII to Regulation (EC) No 1907/2006 of the European Parliament and of the Council concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) as regards methanol (3 pages + Annex 2 pages, in English).
- **6. Description of content:** This draft Regulation relates to a new entry in Annex XVII to Regulation (EC) No 1907/2006.

It would restrict the placing on the market for the general public of windscreen washing fluids or defrosting fluids and denatured alcohol containing methanol in a concentration equal to or greater than 0.6% by weight.

Application of the restriction is deferred for 12 months to allow stakeholders sufficient time to adapt and achieve compliance.

7. Objective and rationale, including the nature of urgent problems where applicable: The exposure to methanol present in windscreen washing fluids or defrosting fluids and denatured alcohol in a concentration equal to or above 0.6% by weight poses a risk to human health, in particular a risk of death, severe ocular toxicity or other severe effects of methanol poisoning.

The proposed restriction aims to reduce the incidence of severe methanol poisoning following consumption by chronic alcoholics and sporadically by non-alcoholics of windscreen washing fluids or defrosting fluids and denatured alcohol used as cheap substitute for consumable alcohol.

The 12 months of transitional period before the application of the proposed restriction will allow stakeholders sufficient time to comply with the proposed restriction in particular to allow the sales of stocks and to ensure adequate communication within the supply chains.
