Title: The Candidate List of SVHCs Add 4 Substance, Update to 201

Date: 16 July 2019

Abstract: 16 July 2019, ECHA added 4 new substances to the Candidate List of substances of very high concern (SVHCs). The authorization now contains 201 substances. The new substances to the Candidate List possess the carcinogenic, toxic to reproduction, persistent, bioaccumulative and toxic (PBT) and very persistent and very bioaccumulative (vPvB) properties.

On 16 July 2019, ECHA adds four new substances of very high concern (SVHC) to the Candidate List. Up to now, the SVHC list is updated to 201 items.

Following are the new SVHC substance and updated entries on 16 July 2019:

3	2,3,3,3-tetrafluoro-2-(hept afluoropropoxy)propionic acid, its salts and its acyl halides (covering any of their individual isomers and combinations thereof)	-	-	Equivalent level of concern having probable serious effects to the environment (Article 57(f) - environment)	Processing aid in the production of fluorinated polymers.
