I. Summary record of the proceedings

Item 1 – Welcome and introduction

1.1 Opening by the Chair of the Forum

The Chair welcomed all the participants. She announced apologies from Forum members from FR, LI, ES and MT and informed on the appointed proxies.

The Chair informed that the quorum requirement was met.

1.2 Adoption of the agenda

The Chair indicated the changes in the agenda (Content IV, Annex 1) and the agenda was adopted.

1.3 Declarations of conflicts of interest with regard to agenda items

The Chair requested all participants to declare any potential conflicts of interest for any of the agenda items, according to Article 9(2) of the Rules of Procedure. No conflicts of interest were declared in the meeting.

1.4 State of play with action points from Forum-19

The ECHA Forum Secretariat informed on the status of action points from Forum-19 and highlighted that some actions were still open. The Forum agreed to close the action point concerning the status of Article 36 letters (Forum-17, AP 13.5).

1.5 Practicalities and brief recapitulation of results of the written procedures between Forum-19 and Forum-20

The ECHA Forum Secretariat highlighted the document with the results of the written procedures between Forum-19 and Forum-20.

Item 2 – Address by ECHA Executive Director

The ECHA Executive Director brought the issues that were to be discussed that were relevant to ECHA as well to the attention of the participants.

He highlighted that the Forum's advice-giving restrictions' process needed to be streamlined and more workable so that the Forum continues to deliver its advice on time and without engaging excessive resources.

Under the Authorisation issue, he conveyed the message that there were no practical experiences on enforcing such decisions. Even if there were still some concerns on the challenges of such task, it should not deter the Forum from agreeing on the second pilot project on authorisations.

The Executive Director informed that ECHA was facing calls from animal rights' groups to take tangible action towards avoiding unnecessary animal testing. He welcomed the support of the enforcement authorities and encouraged the Member States to be as transparent as possible about the outcomes of their activities in this area.

Finally, he called to the attention of the Forum that the Budgetary Authority and the Commission have decided to reduce ECHA's resources. However, due to the importance of the enforcement activities, the savings will not affect the support that the ECHA Secretariat can provide or impact adversely on the content of the work carried out by the Forum. Board, he recommended for the Forum to find more effective ways of organising its activities, for example, to conduct more WG meetings remotely.

Item 3 – Forum's enforcement activities - Work Packages

3.1 Interlinks

3.1.1 WG progress report

The Chair of the WG presented the status of the work indicating that much progress was made on the chapter describing the NEA follow up of the dossier and substance evaluation and that useful feedback was collected on the Interlinks Workshop on 15 January 2015. This workshop attended by the Forum members and Member State competent authorities was intended especially to discuss the challenges and align positions with regard to NEA involvement in the follow up of dossier evaluation (DEV) and substance evaluation (SEV) decisions.

The WG Chair clarified that the interlinks document was very important for the Forum since its annexes describe the communication and cooperation processes between ECHA and national authorities. This WG will continue to update the document to cover all the processes in which national authorities and ECHA are involved. The Interlinks pilot project (see below, Item 3.1.2) will be useful to capture additional information for those particular duties/processes and the results will be fed into the interlinks document.

3.1.2 Pilot project on the enforceable cases from ECHA screening exercises relating to harmonised classifications

The Chair of the pilot project and the WG in collaboration with the participating countries' representatives drafted the manual for the pilot project to investigate the cases brought by ECHA. The Forum was invited to comment.

3.1.3 Follow-up of ECHA Decisions: updates from ECHA

A document with the summary of the decisions sent by the ECHA Focal point to all Member States was presented. The Secretariat informed the meeting of a particular case where a revoked registration was reinstated following an intervention of the NEA.

An expert requested for a summary of the revocations that have been appealed to be sent to the national Focal points together with some background information of the cases.

3.1.4 Mandate amendment

The mandate of the WG was updated and the Forum adopted the updated mandate (<u>Annex 2a</u>).

3.2 Enforceability of restrictions

3.2.1 WG progress report - Advice on restrictions

3.2.1.1 Discussion on the restriction process

The WG Chair updated the Forum on the status of the work of the WG and introduced the topics for discussion.

A Forum member suggested to re-structure the information in Annex I (Forum recommendations to be considered by dossier submitters, for RAC/SEAC members) and Annex III (Forum Guide for dossier submitters) and create one sting contact and create one structure for dossier submitters) and create one structure for dossier submitters and create one structure for dossier

document only for dossier submitters and another only for RAC and SEAC members. In addition, such documents could be included as annexes in the GDAERF. The WG Chair agreed that re-structuring the annexes was possible.

The Chair suggested discussing the publication of the GDAERF in the next Forum plenary meeting.

ECHA Secretariat informed that a workshop to exchange ideas with the dossier submitters will take place at ECHA in May. The Chair invited a representative of the WG to participate in this workshop to present and encourage ECHA to promote the use of the GDAERF and its annexes related to the recommendations to dossier submitters.

3.2.1.1.1. Open issues with the revised GDAERF

An invited expert of this WG presented the status of the guide that has been revised to streamline and harmonise the approach of the advice of the Forum and presented the open issues.

The Forum agreed on the text included in the GDAERF that the analytical method in the entry has to be assessed on a case-by-case basis depending on each restriction. However, COM has the final decision if a reference should be included in the entry or the recital.

Regarding the Forum's position on costs or resources to be allocated to the enforcement of the proposed restrictions, the WG Chair informed that the WG members could be in the position to make those estimations if the Forum so wishes. Regarding the monitorability, the WG Chair was of the opinion that the Forum should not address this issue in its advice on enforceability since it was not a matter for inspection services.

The Chair encouraged the Forum members to comment on the above issues when providing comments to the GDAERF. If no conclusion could be reached by the WG, the issues should be then discussed in the next Forum plenary meeting.

3.2.1.1.2 Handling the Forum Advice of ammonia salts

The Final Advice of Forum for this restriction proposal was discussed.

Forum agreed to keep the Final Forum Advice that had been delivered to RAC and SEAC unaltered.

3.2.1.1.3 Revision of the working procedure of the Forum

ECHA Forum Secretariat presented the WG's suggestions for modes of operation to provide better advice and support to the process of developing RAC/SEAC opinions on restriction proposals with the aim of enhancing the quality of Annex XV proposals.

The WG would revise the working procedure to reflect the chosen process of advice to RAC/SEAC.

3.2.1.2 Update on the work with Annex XVII entries: Guidelines and Q&As

ECHA Secretariat informed it was preparing guidelines for existing entrances to clarify the scope and wording by means of examples. A public consultation of the guidelines will be launched where the Forum and other authorities would be invited to comment.

The Annex XVII project, which aims to make the reading of Annex XVII friendlier, had a new tool, available on ECHA's website. It consisted of a table of the restrictions that indicated the corresponding entry and the relevant links. Under the same project, ECHA Secretariat launched a batch of Q&As and a second one would be launched in Q2 2015.

3.2.2 WG progress report: analytical methods

3.2.2.1 Discussion of the compendium

The WG Co-chair presented a revised roadmap for the project of creating a compendium of recommended analytical methods for the enforcement of restrictions. The WG Co-chair presented the contents of the provisional compendium and requested for Forum to assist the WG on the best way to handle methods for restrictions without limit value (NLV Restrictions). The WG discussed the problem and identified the possible options for handling NLV restrictions.

The Forum agreed on the best option and the WG would tackle the methods for restrictions without a limit value taking in consideration the voted option. The publication of the compendium was foreseen for Q3 2015.

3.2.3 Mandate amendment

The mandate of this WG was revised and the Forum adopted the updated mandate (Annex 2b).

3.2.4 Participation of the Forum in the process of developing standards

The Chair informed the meeting that in February 2015, DG GROW informed the WG Enforceability of Restrictions about the analytical methods proposed by DG GROW to be included in the Commission Annual Union Work Programme (UWP) for Standardisation 2016. The WG was invited to comment or make additional suggestions on this proposal. However, the WG didn't provide any specific comment since the commenting period was short and the WG was not mandated for such specific activity.

The Chair recalled that in 2014 the Forum replied to COM's proposal to have the participation of the Forum in the process of developing standards by being available to reply to standardisation requests related to REACH Annex XVII during the development of the standard by the relevant European Standard Organisations (e.g. Forum as advisory body, providing opinion in the progress and monitoring the process). However, COM had not confirmed whether such participation was possible or not. Consequently, the Forum had not prepared to tackle these requests.

The WG suggested for DG GROW to consider the previously provided Forum advice on enforceability and highlighted the importance of the continuation of Forum's consultation on the proposals for development of standard methods for **REACH Annex XVII restrictions.**

COM agreed to inform the Forum in the next plenary meeting about the state-ofplay with the UWPs 2015-2016 and inform about the plan to involve the Forum.

3.3. REACH-EN-FORCE-4

3.3.1 WG progress report

considered the availability of analytical methods and its costs, the Member States preferences and the restrictions included in RAPEX notifications.

The WG Chair highlighted that the Forum members might need to consider the involvement of other national authorities in the execution of this project. Moreover, the Member States should select the relevant restrictions from the proposed list according to their own national priorities and share its national results for other restrictions that were not part of this initial list.

3.3.2 Discussion and adoption of detailed scope of REF-4

The Forum discussed the proposed list of restrictions prepared by the WG.

The Chair requested the WG to add non-consumer entries to the proposed scope of the project. The Forum members should then be consulted on the restrictions they would select from the new list to accurately define the scope. If possible, the Member States could inform the WG on the average cost of testing such restrictions.

The Forum agreed to additionally inform the WG on national inspections on restrictions that would happen during the operational phase of REF-4 but out of the scope of the project.

3.3.3 Mandate amendment

The mandate of this WG was revised and the Forum adopted the updated mandate (<u>Annex 2c</u>).

3.4. Prioritisation of REF projects

3.4.1 WG progress report

The Chair of the WG reminded the Forum members that the period for submitting proposals for REF-5 was still running until 30 April. The WG would produce a registry of obligations that were covered in previous projects and will assess the proposals by Forum-21.

COM suggested revisiting REF-1 and REF-2 project's scope to follow them up and assess whether there were improvements on those subjects.

The WG Chair clarified that all the previously submitted proposals would be reassessed and if relevant, it could be considered to have a repetition of the issues previously addressed.

3.4.2 Mandate amendment

The mandate of this WG was revised and the Forum adopted the updated mandate (<u>Annex 2d</u>).

3.5 Pilot project on CLP: Child-resistant fastenings

3.5.1 WG progress report

The WG Chair summarised the WG activities that were mainly focused on the elaboration of the draft manual. The manual was available for Forum members to comment and then the WG would prepare a new version of the manual, for adoption.

3.5.2 Mandate amendment

The timeline was revised and the Forum adopted the updated mandate (<u>Annex</u> <u>2e</u>).



3.6 REACH-EN-FORCE-3

3.6.1 WG progress report

The Forum Chair informed on the status of the project and the provisional general results from the second phase of the project.

3.6.2 Mandate amendment

The timeline was revised and the Forum adopted the updated mandate (Annex 2f).

3.7 Projects on authorisation

3.7.1 Pilot authorisation - first pilot project: WG progress report

The Forum took note of the progress report submitted by the WG and the operational phase of the project that has been running with no difficulties.

3.7.2 State of play of Article 66 downstream user notifications and conclusions on applications for authorisation conference

The meeting was informed by ECHA Secretariat on the status of the consultation referring to the notifications from downstream users of authorisation holders based on Article 66 of the REACH Regulation. A compilation of responses to comments from Forum members would be distributed as well as the measures that will be taken by ECHA. The submission tool and the web page should go live at the end of Q2 2015. ECHA was exploring the possibility to inform NEAs directly through the Portal Dashboard for NEAs (the system that will replace RIPE), instead of going via the competent authority.

Moreover, ECHA Secretariat briefed the meeting on outcome of the conference on "Lessons learnt on Applications for Authorisation (AfA)" that was held in ECHA on 10-11 February 2015 to assess the experiences gathered from the 28 AfA dossiers. ECHA has received 28 applications for authorisation from 44 applicants, for which 24 were approved by RAC/SEAC and three were already adopted by COM. From the conference, it was concluded that the AfA system worked and that it applies some pressure on industry to substitute their substances for safer ones. Other feedbacks received from the participants would be taken into account by ECHA to improve the system (e.g. simplify the formats, improve guidance, streamline the process, etc.).

3.7.3 Pilot authorisation - second pilot project discussion

ECHA Forum Secretariat presented the proposal for the second pilot project on authorisation with the aim to further develop and test the enforcement practices when dealing with authorisation decisions.

The Forum discussed the scope and the timeline of the proposed project and agreed to set a WG to initiate the development of the manual.

3.7.4 Mandate amendment of first pilot project

The mandate of this WG was revised and the Forum adopted the updated mandate (<u>Annex 2g</u>).

3.7.5 Mandate establishment of second pilot project

The mandate of this WG was created and the Forum adopted the mandate (<u>Annex</u> <u>2h</u>).



3.8 Training for enforcement trainers

3.8.1 WG 2014 final report

The Chair of the WG of 2014 presented the final report including the recommendations for future training events based on the feedback received from the participants of the enforcement training event that took place on 20-21 November 2014, covering "Safety Data Sheets and extended SDS" and "Classification and labelling (C&L) of mixtures".

The term of office of the WG was terminated at the time the final report of the WG was adopted.

The Chair highlighted that the participants should be the national trainers and deliver the knowledge gathered in the training event. Therefore, the Chair encouraged the Forum members to appoint staff that would be able to act as multipliers. The Chair suggested for the 2015 WG to deliver to the participants some material that would facilitate the national trainings. In addition, it could be useful if Forum members could share information on their national trainings to motivate and inspire others.

3.8.2 WG 2015 progress report

The WG Chair presented the status of the preparation of the training event, planed for Q3 2015, for which the agenda was adopted by written procedure. The WG Chair received a request from the ECHA Helpdesk suggesting the participation of HelpNet members and Serbian observers in the training as trainees.

A representative from COM would like to participate in the event and make a presentation.

The Forum voted and agreed, by majority, to grant the possibility for HelpNet members and observers to follow the event by webstream. It was planned for this event to resume the broadcasting at the end of each day to summarise and discuss some of the practical cases. In that way, the remote participants would be able to learn about some of the practical cases even if it was not broadcast.

3.8.3 Mandate amendment

The mandate of this WG was revised and the Forum adopted the updated mandate (<u>Annex 2i</u>).

3.9 Electronic Information Exchange System - EIES

3.9.1 WG progress report

The Forum took note of the progress report submitted by the WG. The WG recommended that ICSMS was the most suitable tool for exchanging PIC information between inspectors, with only a limited number of changes needed in addition to the REACH/CLP specifications already agreed with the COM. The consolidation of the first complete draft of the "Guidance document for using the ICSMS/EIES in enforcement of REACH, CLP and, if needed, PIC" is currently in progress.

The COM representative informed that DG GROW would not compromise to develop ICSMS to accommodate the PIC information.

The Forum adopted the WG recommendations and invited DG ENV dealing with PIC to implement the seven specific PIC-related fields in ICSMS.

3.9.2 Mandate amendment

The mandate of this WG was revised and the Forum agreed to change the name of this WG to ICSMS. The Forum adopted the updated mandate (<u>Annex 2j</u>).

3.10 Implementation of RIPE

3.10.1 WG progress report

The Forum took note of the progress report and the Forum was invited to comment on the documents produced by the WG concerning NEA's needs from ePIC for the enforcement of the PIC Regulation and the recommendation for the WG on EIES/ICSMS. The analysis of BPR needs (done by the WG to support ECHA Secretariat in developing a tool to support BPR enforcement) was ongoing. The Forum will be provided with the documents related to this work package when ready. Consultation will be sought with BPR NEAs through BPR MSCAs.

3.10.2 RIPE project progress report

The ECHA Forum Secretariat presented the status update of the project. The release of RIPE version 1.10 was scheduled for early April 2015 and it included the correction of some features. There was a new procurement for the framework contract for the Portal Dashboard (PD)-NEA which did not impact the release date (still planned for Q4 2015). ePIC would be released for NEAs together with PD-NEA in Q4 2015. User management for both tools would be integrated. Under this umbrella, it was under discussion that ECHA would manage the token assignment, by request from a national administrator. The project team was discussing the PIC Article 10 report and if/how the information could be retrieved.

ECHA Forum Secretariat clarified that it was foreseen that the number of administrators for RIPE would be the same as for PD-NEA.

COM reminded the meeting that the Forum did not have the remit for BPR.

3.10.3 Mandate amendment

The mandate of this WG was revised and a new Chair and Vice-chair was appointed. The Forum adopted the updated mandate (<u>Annex 2k</u>).

Item 5 – Update on relevant developments by the Commission

5.1 General updates by the European Commission

The COM representative presented the summary regarding the legal issues, the issues discussed (and to be discussed) in REACH Committee and other fora. The new Commission also brought a new philosophy which was keener to take the initiative, with a greater emphasis on enforcement and with a new strategy for the internal market for goods and services.

He presented the follow-up action related to a practical case on nicotine (Forum-19, Practical issue 1). The Netherlands intended to submit a full CLH dossier to have nicotine classified as acute toxicity category 1 and impose a child resistant fastening. ECHA and COM will assess such proposal.

COM clarified that the 'defence exemption standard' (Code of Conduct) included the statement that all companies shall comply with REACH; the exemptions given would be related to the amount/type of information that such dossiers should contain. How it will be enforced, would be up to the Member State.

He informed that COM was planning on launching a public consultation concerning REACH and CLP enforcement and invited the Forum to participate in the estimation concerning of the construction of the second elaboration of the questionnaire. The Chair and other Forum members raised concern on having a questionnaire on enforcement activities. The Chair suggested for it to be consulted with the Member States. COM agreed that CARACAL should be informed and clarified that the questionnaire would be short (10 questions) and to be displayed on the COM website by the end of 2015. To evaluate who were the respondents (industry, general public, etc.), a set of questions will be created. The aim of the consultation would be to gather information from all perspectives. The Member States' opinion would be registered in the Article 117 report. How the results will be assessed was still under discussion and the Forum was invited to participate in the analysis of the information collected. The Chair requested COM to consult the Forum when elaborating the questionnaire.

A Forum member reminded that the Forum did not have the remit for enforcing the Biocidal Products Regulation (BPR). The member informed the meeting that a paper elaborated by COM presented at the Biocides CA meeting was proposing that the Forum (for REACH, CLP and PIC) could play a role in supporting Member States enforcement and control of biocidal products and articles. The member suggested for the Forum to re-discuss this issue and take a formal position.

The Forum member informed that an experts group on internal market for products (IMP) had a sub-group that explored topics such as ICSMS, cross border cooperation, indicators for enforcement, which were topics addressed by the Forum. Therefore, it could be interesting to liaise with such groups to exchange views. The Forum was invited by COM to send one representative to attend the meeting of such an expert group.

5.2 Final report of the ENFIND project

The COM representative informed the meeting on the status of the project of enforcement indicators. The final report was at the final stage of its preparation and a list 50 indicators would be proposed for the different levels (EU, Member States and Forum). COM was developing a system to implement those indicators and would be delivered to the Forum at the next Forum meeting. COM representative encouraged the Member States and Forum to use them.

The Chair suggested having a discussion on the implementation of the enforcement indicators at Forum-21 based on the final report of the ENFIND project.

Item 6 – Break-out groups session

6.1 Discussion of topics

The participants separated into groups for discussing their selected topics.

Item 7 – Enforcement projects in Member States

7.1 CY: 2014 Campaign on the classification, packaging and labelling of bleaching agents

The Cyprus Forum member presented the national campaign and its results that controlled products with extreme pH values placed on the Cyprus market. During the campaign, the enforcement authorities took samples of products placed on the market with high and low pH, measured its pH and checked it against the labelling and packaging requirements, according to CLP and DPD.



The companies were also requested to present any documents that attested that their product was not corrosive. It was found that circa 20% of the investigated products were appropriately classified, labelled and packaged.

At the end of the project, the authorities could better provide guidance to formulators in Cyprus (SMEs) on the respective classification, labelling and packaging requirements.

Item 8 – Cooperation with other networks 8.1 CLEEN: Forum collaboration

A Forum member presented a joint project proposal between Forum and CLEEN on *Chemicals labelling under European legislation*. Since at European level, the enforcement of chemicals legislation is coordinated by these two bodies, such cooperation would allow an integrative approach on the labelling of chemicals. Much material was already available that would facilitate the work of the project members.

A Forum member expressed that at national level there were measures in place to deal with the issue. Another member informed that CARACAL had set a subgroup to deal with C&L issues. The Forum agreed to mandate the WG Prioritisation of REF projects to assess the proposal.

8.2 ADCO meeting report

A Forum member reported on the meeting of the Administrative Cooperation (ADCO) groups related to the enforcement of market surveillance legislation. There were 17 different ADCO groups and each of them had an appointed Chair. The Chairs of the 17 ADCOs participated in a meeting on 12 March where the Forum member participated on behalf of the Forum.

He referred to the discussion concerning CN codes in which DG TAXUD proposed to address the ADCO's concerns, for instance, the broadness of CN code groups and correctness of codes used by exporters. The ADCO groups were setting up their website and were drafting an over-arching document that would refer to all of ADCOs' guidance documents. The group discussed the joint actions for 2015-2016 concerning e-commerce.

Overall, it would be interesting for the Forum to follow the discussions taking place in these groups since many issues were also dealt within the Forum. COM would provide some general information of the ADCO groups to be forwarded to the Forum members.

A Forum member recalled the participation of SLIC Chemex in previous Forum meetings. The Chair agreed to contact this network and invite them to update the Forum on their activities.

8.3 IMPEL project: Follow-up

The Forum member that was mandated to participate in the project on behalf of the Forum reported that the second phase of the project was ongoing. The project focused on increasing the awareness of authorities and industry about the interactions between REACH and Industrial Emissions Directive (IED) and identifying the current practices mainly relating to the existing tools for chemical substances for handling the items in IED's permit procedures. The task of the IMPEL WG was to identify a set of data of the chemical substances needed for the set of data of the chemical substances needed for the permit applications to ensure that substances were addressed adequately throughout the life-cycle of the permit. Moreover, the WG should identify the procedures to deal with the obligation to use less hazardous substances.

The Forum member informed that it was not possible to attend the workshop in November 2014 but a presentation was submitted. The second version of the draft report was circulated on 24 March 2015 to collect comments from the project members.

Item 10 – Practical issues for enforcement of REACH and CLP

Issue 1 - To what extent, and how is the requirement to inform on the breakthrough time and thickness of specified glove material in the SDS enforced when it comes to mixtures? Are there any guidelines the authorities have worked up on how the breakthrough times can be determined concerning mixtures?

The submitter presented the issue and summarised the comments received from other Forum members and ECHA. A proposed conclusion was discussed and agreed.

The Forum agreed with the conclusion of the issue that was edited during the meeting.

Issue 2 - How do MSs handle individual registrations for chemicals for which a SIEF exists?

ECHA Forum Secretariat presented the outcome of the consultation round with the Forum members on this issue. The Forum would address this issue in the next Forum meeting.

Item 11 – Updates from the ECHA and ECHA Forum Secretariat

11.1 Article 117(3) - Animal testing without a regulatory decision on testing proposals: report of the feedback

ECHA Secretariat presented the summary of the ECHA report on animal testing proposals and the compilation of the feedback from NEAs on the survey launched by ECHA.

ECHA Secretariat informed that, following the Ombudsman cases, ECHA will publish its findings and would requested the collaboration of NEAs to follow-up the potential incompliances of Article 13(1). ECHA encouraged the publication of the outcomes of the NEAs' activities. ECHA's communication plan foresees an increase of more similar cases that would be communicated to Member States (CA/NEAs).

The Forum agreed that ECHA would send to NEAs the cases for enforcement. In turn, NEAs would consider informing ECHA on the outcome of the investigations for ECHA to publish on its website or refer to the NEA's website.

11.2 Guidance updates

The Forum took note of the updates from ECHA Guidance. It was the same document to be submitted to CARACAL.



11.3 HelpNet and CLP

The Chair informed that the room document was amended.

The ECHA Secretariat informed on the relevant outcomes of the discussion held in the HelpNet meeting and CLP Workshop, held at ECHA on 18 March. The participants of that meeting were positive to provide read-only access of REACH/CLP sections of HelpEx to Forum.

A CARACAL sub-group on labelling and packaging would work further on fold-out labels, multi-lingual labels and labelling of over packs and packaging that contained different chemicals with different classification.

The Chair requested to keep the Forum informed on the work developed by this sub-group. The Chair informed on the decision made by the Forum on the participation of HelpNet members in the Forum Train the trainers' event (see 3.8.2).

11.4 Update on the work on an SDS checklist

The ECHA Secretariat summarised the final SDS checklist produced by ECHA in cooperation with the Forum. The use of this tool was encouraged in as many Member States as possible to increase the harmonisation on how SDSs were checked. It was also possible to have it tailor-made according the NEA's needs. It was highlighted that it could also be a good tool for industry to make its own self-assessment.

Some Forum members expressed the appreciation of the tool and the willingness to use it in their routine work.

The Forum agreed to test the tool for the next three months and provide comments on the experience.

11.5 Outcomes from the "ESH Professionals" pilot project 2014 with Member States and the integration REACH into ESH systems

The ECHA Secretariat presented the project originated from a work package from the CSR Roadmap and the results from the first phase. It was initiated in 2014, to help Environmental Safety and Health (ESH) professionals to develop awareness and understanding of downstream user obligations under REACH and to encourage them to integrate REACH obligations into current activities undertaken to fulfil other regulatory requirements. The project would be prolonged and the Forum members were invited to signal their interest to participate.

An invited expert shared the positive experience of participating in the first phase of the project where national institutions and industry were involved and would be interested in continuing. The expert indicated that ECHA provided great support and tools. It was suggested to translate the tools to have additional information to be disseminated.

11.6 Update on intermediate verification work supporting the prioritisation of Candidate List substances for inclusion in REACH Annex XIV

ECHA Secretariat presented the status of the work concerning intermediates which included the continuation of checking substances on the Candidate List and checking SVHCs identified in full registration dossiers, where intermediate uses have been declared by the registrant. Article 36 letters would be sent to the registrants, when relevant. It was highlighted that, when it was not possible for ECHA to be sure that the substance was used as an intermediate, ECHA took the registrant. 11.7 REACH and other legislations, synergies in the use of information at downstream user level

ECHA Secretariat informed on the update of this project, started in 2013, to explore how the supply chain information related to the fulfilment of REACH obligations (SDS, extended SDS) could support the downstream users to fulfil their obligations concerning other legislation. ECHA will organise a workshop on 16-17 April 2015. A Forum member would make a presentation during the event and the member was invited to brief the Forum in the next Forum meeting.

11.8 Implementation of REACH 2018 Roadmap

ECHA Secretariat informed that the implementation phase of the Registration Roadmap 2018 had started. ECHA would assess the material available for the companies and create other support material if needed. Under the umbrella of this project, the Communicator's network was created since one of the major concerns was the low awareness of the registration obligations by SMEs.

20 Members States participated, being represented by the HelpNet correspondents or the competent authorities, and representatives of industry organisations. The Forum was invited for inspectors to join as multipliers in the awareness raising efforts. ECHA Secretariat will keep the Forum informed on the ongoing activities of the project.

The Chair agreed that inspectors have contact with the companies and might be in a position to share the information. ECHA Secretariat would share the contact points from the different Member States so that the NEAs can liaise with them.

11.9 Secure-CIRCABC Project

ECHA Secretariat informed on the new features of the collaboration platform used by ECHA to share information with external stakeholders. ECHA's security requirements and the feedback collected from the users were the main reasons to consider an update of the collaboration platform. It was decided that it should be based on the existing CIRCA-BC platform. Therefore, additional features to make the tool more secure and efficient were developed. In the next few months, there will be an update of the instructions and training on the new functionalities will be given. The migration of the documents to the new platform was foreseen for the end of July.

Some Forum members expressed concerns with the new two-factor identification as well as the challenges of using some of the proposed features.

The Forum agreed for the applicability of the new features to be discussed at the Forum-21 meeting and to assess which ones would be relevant for Forum's activities.

Item 12- Updates from the ECHA Forum Secretariat

12.1 Forum's rules of procedure

ECHA Forum Secretariat informed that the Forum RoPs were adopted in the Management Board member with the Management Board member with the construction of the state of the construction of the constr

observed a minor inconsistency in Articles 9.7 and 9.8 related to the fact that while the first sentence of 9.7 refers to members and invited experts, the remaining sentences refer only to members. ECHA Forum Secretariat took note and would amend it at the next revision. In the meanwhile, it was proposed for the formulations in 9.7 and 9.8 to pertain also to invited experts as far as applicable. The Forum agreed on this approach.

12.2 New version of Forum's WG description

ECHA Forum Secretariat informed that a room document "Description of Working Groups of the Forum – procedures and guidelines" was available for comments.

The document revised the working procedure for the work of the WGs adopted by Forum in 2008 to take into account the current practices for the organisation of the work of the WGs. The document introduced the guidelines for the good conduct of the work of the WGs agreed by the Forum at Forum-18 during the dedicated discussion on the optimisation of the work of the Forum. The document also introduced the new template in use to report on the progress of the WGs.

The comments from the Forum would then be compiled, the document revised and adopted by written procedure. When adopted by the Forum, the document will supersede the working procedure adopted in 2008.

12.3 Criteria for future requests of access to documents (AtDs)

ECHA Forum Secretariat informed the Forum on the progress of the development of the ATD criteria, considering the comments received after Forum-19. After a final consultation with the ECHA legal unit, new additional comments were provided resulting in some further revision of the document. Therefore, the Forum was invited to participate in an additional consultation round. A written procedure for adoption will then be organised afterwards.

12.4 Invited experts to Forum meetings – evaluation of the system

ECHA Forum Secretariat highlighted the results of the analyses and informed on the future scenario concerning invited experts. A slight increase was observed on the involvement of the alternate members and a constant level of participation of invited experts in the Forum meetings.

The ECHA Secretariat will continue this system for the next three Forum plenaries (Forum-20 to Forum-22) and invited the Forum members to maintain the level of involvement of the invited experts to the plenary meeting and increase the involvement of alternate Forum members in the chairing or co-chairing of working groups.

The Chair highlighted that it was clear that the Member States appreciated the reimbursement of invited experts and it was beneficial to bring more views to the Forum and its meetings. A Forum member enhanced the role of the experts in the WG which, in many cases, take over great responsibilities and workload.

The COM representative added that COM would continue to support the Forum.

Item 13 – A.O.B.

13.1 Debriefing of the meeting with Forum Chairs and ECHA's directors

The Chair summarised the discussions held at the end of Day 1 of the meeting with ECHA's directors.



13.2 Manual for New Zealand EPA

An invited expert informed the Forum that a representative from the Environmental Protection Agency in New Zealand visited its organisation and was interested in learning how the enforcement of the chemical legislation was carried out. To provide the visitor with a better view of the harmonised enforcement actions, it was requested to grant access to the manual of one of the Forum's projects with a non-disclosure caveat.

The Forum agreed to provide the manual of the finished project, REF-2.

Item 15 – Closing of the meeting

The Chair thanked the participants, the COM and the ECHA Forum Secretariat for their contributions and support. With that, she closed the meeting.
