According to REACH, if SVHC is present in products in a concentration that greater than 0.1% and the volume for export is less than 1 tonne, downstream importers shall be notified with such information for communication and also provided with certifications. However, if SVHC is present in products in a concentration that greater than 0.1% and the volume for export is greater than 1 tonne, notification of such information to ECHA is necessary.

C&K Testing advises companies that intend to export their products to the EU market should track on SVHC news and confirm whether they are obliged to perform relevant obligations. We will continue to keeping an eye on the SVHC news and share the latest news with you.
